Visitors to "The Quest for Immortality: Treasures of Ancient Egypt" May Gain Free Entry on First-Come, First-Served Basis or Opt to Get Advance Passes at **Ticketmaster**

Washington, DC--Visitors to The Quest for Immortality: Treasures of Ancient **Egypt**, at the National Gallery of Art, may gain free entry on a first-come, first-served basis every day, throughout the exhibition, June 30 through October 14, 2002. Starting Friday, June 21, people may also order advance passes for the dates of July 6 through October 14.

Advance passes will be timed on the half-hour, from 11:00 a.m. to 4:00 p.m., Monday through Saturday, and 12:00 noon to 5:00 p.m., on Sundays. The first public hour of each day will be reserved only for first-come, first-served visitors.

A maximum of six advance passes per order may be obtained at Washington area Ticketmaster locations and at Hecht's stores, for a service charge of \$2.50 per pass.
